The flag of AIBOA was hoisted by Com P R Rajagopal President of our organisation amidst thunderous applause and reverberating slogans by the participants of more than 300 plus comrades drawn from all over the country in the august presence of the leaders of Canara Bank Employees' Union, All India Bank Officers' Association and Central Office functionaries. Our President in his speech expressed his happiness and that the proceedings of the historical two days conference has been flagged off for a successful completion.





#### January 25, 2016

#### **DELEGATES SESSION:**

The session presided over by President Com P R Rajagopal, commenced its proceedings sharp at 9.45 hours. Com Ajay Manjrekar General Secretary, Canara Bank Employees' Union the inaugurator of the session

The second day session commenced with an exclusive womens' convention presided over by Com P R Rajagopal with the convenor Com Jansi Rani.

Com Vimala an activist of AIDFW a former Corporation Bank Employee in her

brilliant speech touched the stark realities of life, and also silent promoter of consumerism. She called upon the total participants to rise together to halt the neo-liberal policies of the present Government. 50

of them contributed their concern pertaining to the work pressure, lack of attention of the administration etc.,

At the end, the convention

elected Com Jansi Rani as the Chairperson, Com Sauntarya as Convenor and Com Vasanti Milind Sathe as the Joint Convenor of the Womens' Council of CBOU.



CONTINUATION OF THE DELEGATE SESSION:

There was tremendous response from the delegates on the subjects mentioned in the report of the General Secretary. Our conference witnessed a change in the approach of the participants (ie) focus were on the organisation , need to concentrate to add the new membership certain specific issues confining to the North Eastern Region etc., In all 30 delegates participated in the debate. Due to paucity of time, 9 delegates had agreed to withdraw their names.

#### THE FIRST MAN OF CBEU GREETS:

Com G V Sambasiva Rao, President of Canara Bank Employees' Union, who was unavailable in the



first day programme, elaborately dealt with the present day pressures and also the need to combat the offensives together with the Officers with in the Bank as well as outside the Bank in Unison. He assured total support to Canara Bank Officers' Union and its growth in the days to come.

Com V Ramabhadran Joint Secretary AIBOA, and General Secretary Central Bank Officer's Union Tamil Nadu, greeted the conference. He placed the dangers faced by the banking work force in the



forms of Banking Sector Reforms, Opening of Small and Payment banks , the off repeated merger talks and the introduction of the retrograde government policies and the need to fight against such issues. The TWIN BANNER movement only is fighting such dangers and he exhorted to gain more strength to the CBOU to fight against such issues.

Com Gunasekaran, Treasurer of AIBOA and President of AIBOA Tamil nadu in his greeting address to the conference expressed happiness the way with which the youngsters

- CIBIL Report for Gold loans making undue delays in rural branches ultimately loosing our business
- Prob Officers heading branches without any experience and hardships faced by them
- Issues in Grid based clearing especially the fraudulent cheques paid and the non availability of Ultra violet lamps in clearing branches.
- To improve the communication channels
- Officiating allowance to Officers heading branches
- Non availability of ladies toilet in branches where lady employees/ officers are posted
- ✓ To market the quality success of the CBOU to young colleagues
- Suggestion on Gold Loan Sanction Scheme to avoid frauds – reappraisal at regular intervals
- ✓ The role of the Business correspondents and the need of the organisation to organise them.
- ✓ Pressures on sale of third party products to branch in charges.
- ✓ To take up with the Management on the use of our Bank's logo in the CANPAL

Com Ajay Manjrekar, General Secretary Canara Bank Employees' Union in his third presentation before the conclusion of session explained the role of the Union in the proposed re organisation and wished that the Officers movement in CBOU shall take the re organisation to its advantage for building up the movement. Com Ajay extended total support for the enhanced co ordination of the two Unions and assured the house that the same shall come from the top to the branch level. The General Secretary in his reply and summing up of the delegate session appealed to the participants to move extra mile to build a Strong CBOU under the banner of AIBOA. - To authorise the President and General Secretary to take appropriate steps to realise the dream of our leader Late Com R J Sridharan in the project.
- To ratify the action of the Union for entering into an agreement for development of the property with Mr V Natarajan the service provider/ facilitator
