**SUB :: TRANSFERS EXERCISE 2020**

**REF :: OUR LETTER CBOU/13/2020 & 14/2020 Dated : 20.04.2020 & 21-04-2020**

A very good morning Sir. Amidst the fear of pandemic Covid-19 , today (30.05.2020), MHA has released its revised guidelines on phased reopening of all activities outside containment zones and strict enforcement of lock down in containment zones where in it has been mentioned that there shall be no restriction on inter-state and intra-state movement of persons and goods and no permission /approval/e-permit will be required for such movements subject to individual state's assessment of the situation on public health. Under this environment, the season for annual general transfer is to be kick started and our union expects our Bank to come out with guidelines shortly.

Our union had represented to your office through the referred letters, regarding permitting certain relaxations during annual general transfer exercise and we hope that they will be pursued favourably. We place before you yet another request related to the general transfer exercise for your positive consideration.

In peer banks like SBI, there prevails the facility for officers who are subjected to the transfer exercise with the nomenclature FACILITY OF LEASED ACCOMODATION AT A PLACE OF CHOICE.

Such facility permits officers in Scale I to VII to avail leased accommodation facility anywhere with in the country.

Hence Our Union suggests and requests the bank to

1. Permit transferred officer to retain the existing leased accommodation even in case of transfer to a different place.
2. Permit to absorb the rent of such existing leased accommodation, irrespective of the ceiling prescribed for the place where the officer is presently posted.
3. Permit travel by own car wherever such request is made by the officer and reimbursement may be on realistic basis.

*As in the current year, the fear on pandemic Covid-19 has taken the centre place, we hope our representation will be considered favourably with necessary earliest guidelines, considering the enthusiastic support being extended by the employees in ensuring uninterrupted customer service during the entire difficult phase started from last week of March 2020.*
