COMRADE MAS

Comrades!

Our beloved president of the Union Comrade M A Srinivasan, affectionately called MAS is laying down his office upon Superannuation as Senior Manager of Thambu Chetty Street Branch Chennai on 31.08.2019.

It is pertinent to mention that he is retiring at the time where the Bi-Partite negotiations are reaching a crucial stage. Being part of the wage negotiation team representing AIBOA for the previous wage negotiations and one of the signatory for the joint note, comrade MAS has abundant knowledge on the methodology and nuances of wage revision exercise.

Hence during the current phase of wage negotiations which started during Oct 2017, whenever there is any misguiding propaganda against the bi-partite concept, content and exercise, a knee jerk reaction from the desk of comrade MAS will always be there with elaborate statistical details on possibility, impossibility and reality.

Being a MBA Graduate, Com MAS always has a flair on handling credit portfolio and he used to be admired for his extempore handling of advances, balance sheet analysis during scale promotion classes.

Comrade MAS had been blessed with the unique opportunity of starting his career in the bank with the stalwart of Canara bank Employees Union, Comrade T N Aravamudhan at Perambalur Branch. On promotion, he was posted to Kolkata where he met Comrade Ananthu and it was those period which provided comrade MAS a new opening to read, discuss and get updated on Officers service regulations and disciplinary action proceedings. On return from Kolkata, comrade MAS had well established the presence of CBOU in Coimbatore / Nilgris / Erode Districts with an excellent coordination with CBEU.

His performance in CBOU had given him an induction in AIBOA kovai District Committee

and he was identified as an emerging leader. In the meantime, Comrade MAS worked in Dindigul Main and Poomparai (Kodaikanal hills) and returned back to Coimbatore region. On official front, he got two further elevations. In organisational front, he was entrusted with the responsibility of functioning as a central committee member. His liaisons work ably supported by Comrade Asokan and Comrade Ponnusamy in Coimbatore Region which became a separate circle subsequently, resulted in substantial increase in membership for CBOU.

Comrade MAS was co opted to the post of General Secretary and the letters from the desk of GS during his tenure are numerous and on various issues being faced by the officers besides suggesting on various welfare measures.

His letters to Head office on the relaxations available as per Govt Guidelines on placement for officers under PWD(Persons with Disability) category and placement for women employees needs special mention.

The copy of such letters were handed over to Direct Recruit officers along with our Service conditions book let and at the entry level itself the officers are offered with their salary and other benefits and relaxations offered by Govt guidelines to women officers and officers belonging to PWD category.

In 2014, model Transfer policy document was formulated taking cue from the mutually agreed transfer policy documents in force in other banks and the same was submitted to Head office, explaining the difficulties faced by officers due to non availability of codified transparent fair transfer policy in our bank.

The implementation of a codified, transparent, fair transfer policy for officers was continuously impressed upon the Management on every occasion CBOU meet the top executives and the day is not far off to get our genuine demand see the light of the tunnel in our bank.


Comrade MAS was elected as the General Secretary of CBOU in the All India Conference held at Bengaluru in January 2016.
